Moved by Barnett, second by Eddy to accept the recommendation of Engineer Riherd and approve a Utility Permit for Dumont Telephone Company to install fiber service lines near intersection of C33 & Marsh Avenue. All ayes. Motion carried.

Moved by Eddy, second by Barnett to accept the recommendation of Engineer Riherd and approve a Utility Permit for Windstream Iowa Communications, LLC to install fiber cable near intersection of Forest Avenue & Hwy 57. All ayes. Motion carried.

Moved by Heidenwirth, second by Eddy to approve a Class C Liquor License with Outdoor Service and Sunday Sales for Beaver Meadows Golf and Country Club, Parkersburg, Iowa. All ayes. Motion carried.

Board reviewed Mater Matrix scoring for C & T Pork, LLC. Moved by Barnett, second by Heidenwirth to accept the recommendation of Environmental Health Specialist Misty Kroeze and approve the Master Matrix with a score of 440. All ayes. Motion carried.

Board met with Tom Willson, Shell Rock, Iowa to discuss a new hog confinement in Section 26 of Butler Township and to request a reduction in property taxes. Also present were Assessor Michele Shultz, Gary Miller, Idella Folkerts, Joanne Zrostlik, Meli Folkerts, Kathy Fox and Stan Fox, all from Shell Rock, Iowa. Complaints centered around the extreme displeasure with the hog confinement at 32732-200th Street in Section 26 of Butler Township. They all stated reasons why their farms that were once a "paradise" have lost value to them because of the stench from the hog confinement. Environmental Health Specialist Misty Kroeze explained that the County has no local control on whether or not the confinements are built in Butler County, but that the County has shown support for review of the laws in regard to the Master Matrix. She also suggested they contact their legislators to push for changes to the existing, antiquated laws. Assessor Michele Shultz explained that their properties have not lost value due to the proximity of the hog feeding operation and presented data to support that statement.

Board met with Todd Reiher, Clarksville, Iowa to hear his request for termination of an easement on his property. Mr. Reiher stated that it had been used in the past to store piles of dirt or other road building materials. Engineer Riherd stated that it is not actively used as a borrow pit and has no problem with termination of said easement. Board will hold a public hearing on the matter.

No public comment received.
