

MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS HELD ON OCTOBER 6, 2020.

With limited public access to the courthouse due to COVID-19, this meeting was held telephonically with the public able to participate on a limited basis. This complies with Iowa Code section 21.8 that outlines the guidelines to hold an electronic meeting when there are valid concerns that an in-person meeting is “impossible or impractical”.

Meeting called to order at 9:00 a.m. by Chairman Tom Heidenwirth with members Greg Barnett and Rusty Eddy present.

Minutes of the previous meeting were read. Moved by Barnett, second by Heidenwirth to approve. All ayes. Motion carried.

No public comment received.

Director of Public Health Jennifer Becker reported 23 new cases of COVID-19 since last Tuesday with 10 recovered, no hospitalizations and a 5.6% positivity rate.

Board reviewed the Quarterly Reports of the Auditor, Recorder and Sheriff and ordered placed on file.

Moved by Barnett second by Heidenwirth to accept the recommendation of Engineer Riherd and approve a Utility Permit for Cedar Falls Utility at 32735 Westbrook Street. All ayes. Motion carried.

Board met with Susie Jacobs, Butler County Wellness Committee for flu shot request. Full time, part time and family members on County insurance are eligible. Moved by Eddy, second by Barnett to approve shots scheduled for October 13 from 7:00 A.M. to 8:30 A.M. in the EOC. All ayes. Motion carried.

Moved by Barnett, second by Heidenwirth to approve the claims. All ayes. Motion carried.
