

MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS HELD ON AUGUST 1, 2023.

Meeting called to order at 9:00 A.M. by Chairman Greg Barnett with members Rusty Eddy and Wayne Dralle present. Moved by Dralle second by Eddy to approve the agenda. All ayes. Motion carried.

Minutes of the previous meeting were read. Motioned by Eddy, second by Dralle to approve the minutes as read. All ayes. Motion carried.

During Public Comment, Eddy commented as a follow-up to the previous week’s agenda item with Sarah Janssen and Jane Freeseaman regarding cost concerns of the juvenile detention centers. He shared that a meeting has been scheduled to relay these concerns to the North Iowa Detention Center Board.

Alan Stockdale was present to discuss Canadian thistles. Stockdale read a statement regarding his inquiry to the Butler County Conservation and issues with getting Canadian thistles removed. He recited Iowa Code sections and recounted conversations that he had with the State weed commissioner. Matt Morris, Conservation Director, provided a response by giving an outline of the actions taken. County Attorney, David Kuehner, commented that he could not charge anybody with neglect when they were actively working on the issue. Stockdale’s main issues included communication lapses, and with the weeds going to seed and possibly spreading in the future. Barnett mentioned that there has been weed complaints in the past and there has never been a problem. Eddy commented that he appreciated Stockdale coming in and that moving forward Eddy asked Stockdale to remain vigilant and notify the County in the spring to address the Canadian thistles.

Susie Jacobs, Wellness Committee, discussed the Wellness Check Clinic. Jacobs stated that Unity Point is not doing the Wellness Check Clinics now as they are short staffed and she is seeking other options to still schedule the Wellness Check in the fall. Dralle moved to approve the Wellness Check Clinic, second by Eddy. All ayes. Motion carried.

Board reviewed Access Systems Agreement. Moved by Eddy to approve the agreement, second by Dralle. All ayes. Motion carried.

Motioned by Eddy, second by Dralle to approve claims. All ayes. Motion carried.
